AND, WHEREAS, the matter was considered by WRC in its 282nd Meeting held on October 24-26, 2017 and the Committee decided that "...The institution has applied for change of affiliating body from Barkatullah University to RKDF University. Barkatullah University has given the NOC.

Hence, change of affiliation is permitted. This decision was taken earlier also in the 276th meeting regarding the B.Ed. course."
